

ORDINANCE NO. 25

AN ORDINANCE AMENDING ORDINANCE 13, WHICH IS AN ORDINANCE REGULATING THE IMPOUNDING AND TAGGING OF DOGS

THE TOWN BOARD OF THE TOWN OF GREY CLOUD, WASHINGTON COUNTY, MINNESOTA DOES ORDAIN:

SECTION I IS HEREBY REPEALED AND IN ITS PLACE AND STEAD THE FOLLOWING BE SUBSTITUTED:

SECTION I. LICENSE REQUIRED.

NO PERSON SHALL KEEP ANY DOG WITHIN THE TOWN OF GREY CLOUD WHICH DOG IS OVER THE AGE OF 7 MONTHS WITHOUT SECURING A LICENSE THEREFORE. SUCH LICENSE SHALL BE ISSUED BY THE TOWN CLERK WHO SHALL KEEP RECORDS OF ALL LICENSES ISSUED AND SHALL ISSUE A METAL TAG FOR EACH LICENSE. THE LICENSE FEE SHALL BE IN THE AMOUNT OF \$5.00 FOR EACH DOG AND SHALL BE FOR A PERIOD OF TWO YEARS AND BECOME DUE MAY 1 AND MAY 31 OF THE YEAR THAT IT BECOMES DUE. IF THE LICENSE IS NOT OBTAINED BY MAY 31 OF THE YEAR THAT IT BECOMES DUE, THERE WILL BE AN ADDITIONAL FEE FOR LATE REGISTRATION AS FOLLOWS: FOR EACH ADDITIONAL MONTH OR FRACTION THEREOF, THE SUM OF ONE DOLLAR. THE REGISTRATION FEE SHALL NOT EXCEED THE SUM OF \$12.00

SECTION II IS HEREBY AMENDED BY ADDING TO SAID SECTION AFTER "WITHIN FIVE DAYS OF SUCH NOTICE OF POSTING AND ALL FEES AND CHARGES PAID" TOGETHER WITH A VALID LICENSE FOR SAID DOG.

SECTION VI IS HEREBY REPEALED AND IN ITS PLACE AND STEAD THE FOLLOWING IS SUBSTITUTED:

SECTION VI. EFFECTIVE DATE.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER MAY 1, 1976 AFTER ITS PASSAGE AND PUBLICATION ACCORDING TO LAW.
