“YOU’RE NOT ALONE”

Chances are, when most people think of the Washington County Jail, a positive experience probably isn’t top of mind. But thanks to two social workers operating there largely behind the scenes since April 2021, some jail inmates may leave with better access to resources than when they arrived.

Kesha Marson and Meg Mickulski, who are part of Washington County Community Services posted in the jail, helped launch the jail’s embedded social services program that is aimed to help people in acute crisis during initial intake, as well as with ongoing mental health support during the average stay of 7 to 10 days. Both social workers visit with 8 to 10 people a day, make sure inmates’ families and case workers know they are there, ensure access to required medications, and help correctional staff de-escalate situations. Marson and Mickulski also provide referrals for transportation, housing, job searches, substance abuse treatment, as well as medical and mental health care in hopes of moving forward once people are released.

The team’s main message: “You’re not here alone.”

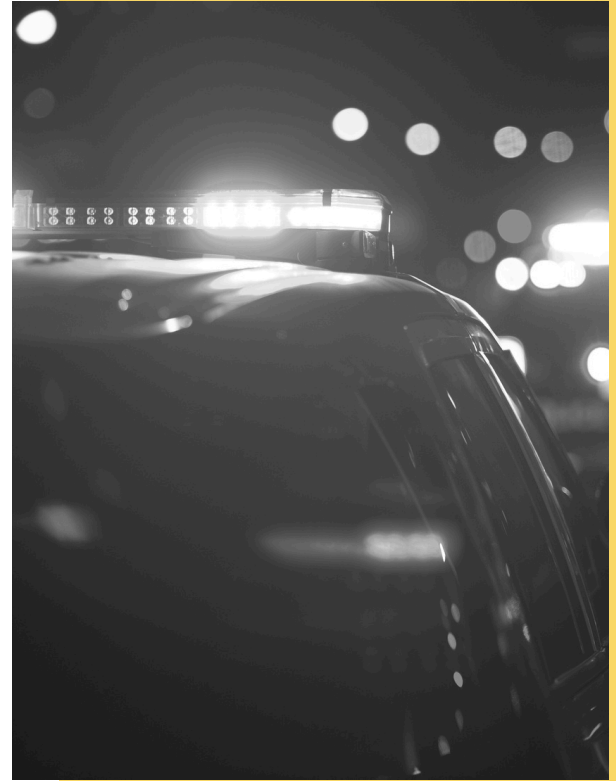

ADDRESS

At 1:35am on July 6, a deputy was dispatched to a reported burglary and assault to which Cottage Grove Police had already responded. As the deputy was arriving, officers had stopped the suspect's pickup southbound on Hwy 61 and the suspect was in custody. After being read his Miranda rights, the suspect told the deputy he had been looking for his girlfriend, who had stopped responding to his calls and texts while out drinking with a mutual male friend. The suspect went to the friend's apartment and found them together. The suspect denied breaking the door to enter and said it had been unlocked and open. The suspect admitted that his emotions got the better of him and he got into a fight with the male friend, who was naked. As the suspect spoke, the deputy noticed a strong odor of alcohol and that his eyes were bloodshot and watery. He agreed to a breath test, which resulted in a reading of 0.138 at around 2:15am. The suspect was subsequently arrested for DWI, in addition to being charged with 5th degree assault. No burglary charges were issued.



MESSAGE FROM THE SHERIFF



Last month marked my 31st anniversary of service at the Washington County Sheriff's Office. Through the years, I've been privileged to serve many roles here: patrol, K9 and investigations, moving from deputy to sergeant, commander, chief deputy and, finally, sheriff. My entire career has been with Washington County, and I've done my best to support our many deputies, correctional officers, and public safety telecommunicators.

In 2024 alone, we've been fortunate to hire 11 additional deputies, 9 correctional officers and 2 telecommunicators, and these public servants will be our leaders in the future. Our most recent swearing-in ceremony, which I consider among the most meaningful events we observe, was on July 6.

I'm proud of all the people who make up WCSO and I know that they are all guided each day by the motto I have followed throughout my time here: "Do the right thing even when no one is watching."
