

ORDINANCE NO. 31

AN ORDINANCE DECREASING THE MEMBERS OF THE GREY CLOUD TOWN PLANNING COMMISSION AND AMENDING ORDINANCES NO. 19 AND 11. THE TOWN BOARD OF THE TOWN OF GREY CLOUD, WASHINGTON COUNTY DOES HEREBY ORDAIN:

SECTION 1. SECTION I OF ORDINANCE NO. 19 OF THE TOWN OF GREY CLOUD IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION I. COMPOSITION: SUCH PLANNING COMMISSION SHALL CONSIST OF SIX (6) MEMBERS AND SAID MEMBERS SHALL BE APPOINTED BY THE TOWN BOARD OF SUPERVISORS OF THE SAID TOWN AND MAY BE REMOVED BY THE TOWN BOARD BY A 2/3 VOTE; OF THE MEMBERS FIRST APPOINTED, TWO (2) SHALL BE APPOINTED FOR A TERM OF ONE YEAR BY THE SUPERVISOR WITH ONE YEAR REMAINING IN OFFICE, TWO (2) SHALL BE APPOINTED FOR A TERM OF TWO YEARS BY THE SUPERVISOR WITH TWO YEARS REMAINING IN OFFICE, TWO (2) SHALL BE APPOINTED FOR A TERM OF THREE YEARS BY THE SUPERVISOR WITH THREE YEARS REMAINING IN OFFICE. THEREAFTER, EACH NEWLY ELECTED SUPERVISOR IN HIS FIRST YEAR OF OFFICE SHALL- APPOINT TWO (2) MEMBERS TO A TERM OF THREE (3) YEARS TO COINCIDE WITH HIS TERM OF OFFICE. VACANCIES DURING A TERM OF OFFICE SHALL BE FILLED BY THE SUPERVISOR WHOSE ORIGINAL APPOINTMENTS VACATED.

APPOINTEES SHALL HOLD THEIR OFFICES UNTIL THEIR SUCCESSORS ARE APPOINTED AND QUALIFIED. EVERY APPOINTED MEMBER SHALL BEFORE ENTERING THE DISCHARGE OF HIS DUTIES TAKE AN OATH THAT HE WILL FAITHFULLY DISCHARGE THE DUTIES OF HIS OFFICE. ALL MEMBERS WILL SERVE WITHOUT COMPENSATION.

SECTION II. SECTION III OF ORDINANCE NO. 11 OF THE TOWN OF GREY CLOUD IS HEREBY AMENDED TO READ AS FOLLOWS.-

SECTION II. ORGANIZATION, MEETING, ETC. THE COMMISSION SHALL ELECT A CHAIRMAN FROM AMONG ITS APPOINTED MEMBERS FOR A TERM OF ONE YEAR:

AND THE COMMISSION MAY CREATE AND FILL SUCH OTHER OFFICES AS IT MAY DETERMINE. THE COMMISSION SHALL HOLD AT LEAST ONE MEETING EVERY THREE MONTHS EXCEPT THAT MEETINGS SHALL BE HELD MORE OFTEN

WHENEVER IT BECOMES NECESSARY TO EXPEDITE THE TRANSACTION OF BUSINESS, THAT IS REFERRED TO IT BY THE TOWN BOARD OF SUPERVISORS. IT SHALL ADOPT RULES FOR THE TRANSACTION OF BUSINESS AND SHALL KEEP A RECORD OF ITS RESOLUTIONS AND

TRANSACTIONS AND THAT SAID RECORDS SHALL BE OPEN FOR PUBLIC INSPECTION. ON OR BEFORE THE FIRST OF FEBRUARY OF EACH YEAR THE COMMISSION SHALL SUBMIT TO THE TOWN BOARD A REPORT OF ITS WORK DURING THE PRECEDING YEAR. EXPENDITURES OF THE COMMISSION SHALL BE WITHIN THE AMOUNTS APPROPRIATED FOR THIS PURPOSE BY THE TOWN BOARD. A QUORUM SHALL CONSIST OF THREE (3) MEMBERS OF THE COMMISSION. THREE ABSENCES PER YEAR SHALL RESULT IN DISMISSAL FROM THE COMMISSION.
